Your Lodge may nominate at most one Brother (Master or Past Master) to stand for election by ballot to each of the above Boards.

Please note that nominations for election to the Freemasons' Joint Hall Committee may be made only by lodges which hold their regular meetings in Mumbai.

District Grand Master expects that a member nominated by your Lodge will, if elected, attend the meetings as and when called for, and undertake and discharge such responsibilities as may be entrusted to him.

It is also necessary for nominated candidates to send a signed declaration and a certificate of good standing as per specimen enclosed. If the nomination is not accompanied by this paper, it will be considered invalid.

Nominations (and Declarations) should be sent to reach the District Grand Lodge office on or before **30 June, 2022. Nominations received after this date will not be considered.**

The elections, which will be by regular ballot, will be conducted under the superintendence of the President of the District Board of General Purposes.

You are requested to read this Circular in open Lodge at your next meeting and record it in the Minutes.
